



Fostering for Anim-Mates

1. I agree to foster dogs / cats / rabbits / guinea pigs orfor Anim-Mates.
2. Any animal for fostering will be offered to me by my assigned Trustee. I have the right to decline to foster an animal and to return any animal to Anim-Mates.
3. I declare that I am over 18 years of age and competent to undertake the responsibility for the animal(s). This responsibility will not be transferred to another person without the agreement of Anim-Mates.
4. An Anim-Mates Trustee will be assigned to support, advise, and encourage me.
5. Any animal(s) in my care will remain in the ownership of Anim-Mates.
6. Any animal(s) fostered by me will be cared for as my own pet(s).
7. Anim-Mates will ensure the animal(s) receive appropriate veterinary care.
8. Any animal in my care will not be released to a new home until a satisfactory home check has been made, the Anim-Mates Adoption Form is fully completed, and my Trustee informed.
9. Anim-Mates is not liable for any damage to property, people, or animals, as a result of fostering an animal, and therefore, I have been advised to take all precautions to avoid any such risks.
10. I will permit an authorised person of Anim-Mates to visit my house at a convenient time to ensure all is well.
11. Anim-Mates reserve the absolute right to reclaim the animal(s) if, in the opinion of Anim-Mates, the terms of this agreement are not adhered to.
12. For at least 3 weeks, dogs will be kept on a lead, and cats will be kept indoors. Kittens will be kept indoors until after neutering.

13. Expenses

Whilst I will not receive payment for my services as a fosterer, I will be able to make a monthly claim for expenses incurred by me.

These expenses will require the prior approval of my nominated Trustee.

That Trustee may delegate approval of expenses to me only in respect of routine vets fees, food and litter.

I can incur the cost of any emergency medical treatment of the animal(s) without prior approval.

Any other expenditure will require the approval of two Trustees before the expenditure can be made.

14. Claiming expenses

For reimbursement for purchases made on behalf of Anim-Mates I will submit original receipts/invoices and a completed official claim form to the Treasurer within the month following that in which the expenditure is incurred. Vet invoices will identify the name of the animal treated. The Treasurer will make out a cheque to me as soon as possible, but usually within two weeks.

I have read, and agree to abide by, the terms and conditions set out above.
